CIRCULAR

This is in continuation to the Circular No. F.88/DDE (IEDSS)/Admn.Cell/2016-17/7019-7026 dated 27.09.2022 wherein instructions were laid down for successful completion of Special Screening Drive using the **PRASHAST** screening checklist in the schools of DoE, GNCTD. The primary objective for conducting the Special Screening Drive in all the schools of DoE, GNCTD was to ascertain and assess the students who may have suspected disabilities and require intervention or remediation to reduce the learning gap reflected in their performances.

Further, listing of Students with "Suspected Disability" in accordance with the 21 categories of disability conditions recognized by RPWD Act 2016 was done by Special Education Teachers/ Teacher -in -charge by administering PRASHAST Part - 2 of the screening checklist.

In this regard, all HOS of the Govt., Govt. Aided and Private Recognized Unaided Schools of DoE, GNCTD are hereby directed to ensure implementation of following instructions pertaining to Students with "**Suspected Disability**" identified under **Special Screening Drive**:


A. Govt. and Govt. Aided schools of DoE

- i) Detail assessment of 3562 suspected students of Govt. and Govt. Aided schools of DoE identified under **Special Screening Drive** in 14 District Resource Centres (DRCs) as per guidelines of PRASHAST screening checklist.
- ii) Remaining 5003 Students with Suspected Disabilities to be assessed at the Assessment Camps to be held at District Level during 2022-23 as per guidelines of PRASHAST screening checklist.
- iii) Applying UDID card for Students identified/confirmation as CwDs/CWSN after assessment at DRCs and Assessment Camps.
- iv) Preparation and implementation of suitable intervention or remedial plan through concerned Special Education Teacher/Teacher-in-charge.

B. Private Recognized Unaided Schools of DoE

- i) Assessment of Students with Suspected Disability to be done through parents.
- ii) Management to ensure UDID card is applied for Students identified as CwDs/CWSN after assessment.
- iii) Preparation and implementation of suitable intervention or remedial plan through concerned teachers/staff members.

All DDE (Districts) are directed to ensure implementation of above mentioned interventions pertaining to Students with "**Suspected Disability**" identified under **Special Screening Drive** in the Govt., Govt Aided and Private Recognized Unaided Schools of DoE, GNCTD.
