- 2. All the fire safety arrangement provided their in shall be maintained in good working conditions at all times.
- Loss of life or property due to non-functional fire safety measure shall be at the responsibility of the Management.
- 4. The trained fire fighting staff should be available round the clock.
- 5. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
- 6. This certificate cannot be treated in any case for regularizations of unauthorized construction.
- 7. "The owner / Occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
